# JEFF WARNER FOR CONGRESS TERMS OF AGREEMENT & PRIVACY POLICY

The Jeff Warner For Congress Campaign (JW4C) respects the privacy of our visitors and all those who come in contact with our campaign—be it in-person, through our Web site, or by mail, phone, or email. We therefore try to collect only such personal information as is needed to provide the information, service, or assistance that you request.

#### **Information We Collect Automatically**

If you visit our Web site to browse, read, or download information:

- Your Web browser automatically sends us (and we may retain) information such as the:
  - Internet domain through which you access the Internet (e.g., yourServiceProvider.com if you use a commercial Internet service provider, or yourSchool.edu if you use an Internet account from your school);
  - Internet Protocol address of the computer you are using;
  - type of browser software and operating system you are using;
  - o date and time you access our site; and
  - the Internet address of the site from which you linked directly to our site.
- We will use this information as aggregate data to help us maintain this site, e.g., to determine the number of visitors to different sections of our site, to ensure the site is working properly, and to help us make our site more accessible and useful.
- We will not use this information to identify individuals, except for site security or law enforcement purposes.

#### **Other Information We Collect**

If you choose to identify yourself (or otherwise provide us with personal information) when you call us, write to us, send us e-mail, or use our online forms:

• We will collect (and may retain) any personally identifying information, such as your name, street address, email address, phone number, and any other information you provide to us. We will use this information to try to fulfill your request and may use it to provide you with additional information at a later time.

We will not disclose such information to third parties, except as specified in this privacy policy.

- If you request information, services, or assistance, we may disclose your
  personal information to those third parties that (in our judgment) are appropriate
  in order to fulfill your request. If, when you provide us with such information, you
  specify that you do not want us to disclose the information to third parties, we will
  honor your request. Note, however, that If you do not provide such information, it
  may be impossible for us to refer, respond to or fulfill your request.
- If your communication relates to a law enforcement matter, we may disclose the information to law enforcement agencies that we deem appropriate.

# How Long We Keep Information

We may keep information that we collect for an unlimited period of time.

# Security

Please note that electronic communication, particularly e-mail, is not necessarily secure against interception. Please **do not** send sensitive data (e.g., Social Security, bank account, or credit card numbers) by e-mail or web forms.

### Cookies

We may use cookies in order to customize this site for return visitors. These cookies are not required for site functionality. Additionally, third-party widgets such as YouTube or Flickr may install cookies depending on their configuration. You are not required to accept any cookies to use this site.

# **Google Analytics**

We may use a tool called "Google Analytics" to collect information about use of this site. This may allow your web browser to automatically send certain information to Google, including, for example, the web address of the page that you're visiting and your IP address. Google may also set cookies on your browser or read cookies that are already there. Any information we collect from Google Analytics is only used to understand or improve how visitors engage with this website.

Google's ability to use and share information collected by Google Analytics about your visits to this site is restricted by the <u>Google Analytics Terms of Use</u> and the <u>Google Privacy Policy</u>.

You can prevent Google Analytics from recognizing you on return visits to this website by **disabling cookies on your browser** or by using the **Google Analytics Opt-Out Browser Add-on**.

In addition to Google Analytics, we may use another Google-provided tool called "ReCaptcha" which, on some form submissions, is intended to tell humans from robots in order to prevent spam and abuse of those forms. The ReCaptcha tool may, in its algorithm, make use of cookies as well as other information like Internet Protocol address, date, time, language, screen size and resolution, and mouse movements while on the page.

The ReCaptcha tool is subject to the same <u>terms of use</u> and <u>privacy policy</u> as Google Analytics. Google also offers more information on <u>how Google uses data on websites</u> <u>using Google technologies</u>.

### Texting

If you provide your cell number, you agree to receive SMS & MMS messaging. You may cancel at any time by texting "Stop" or contact the campaign at 240-736-4487. After canceling, you may receive one more text to confirm your cancelation. You may text "Help" for assistance.

The JW4C will text you information related to the campaign. Message and data rates may apply. Messaging frequency varies, yet is approximately 1-2 messages per week, and may increase to 2-4 messages per week during Primary Voting, General Election Voting or Special Elections.
